

#### **Keeping Geese Healthy**

Wildlife management biologists are concerned to see some local geese with irreparable wing damage. Commonly called "angel wing", where the end of the wing twists outward from the body, this is caused by people feeding the geese bread and other nutrient-deficient foods.

Artificially fed geese may show signs of malnutrition by being underweight or show poor molting or unhealthy wing feathers, Nicole Walker, a Missouri Department of Conservation wildlife management biologist, said.


In natural settings, waterfowl seek and feed on a variety of nutritious foods such as aquatic plants, natural grains, and invertebrates such as insects and worms. People tend to feed bread, corn, and popcorn to geese, which are low in protein and very poor substitutes for their natural foods. Feeding geese can also artificially congregate birds in areas creating a situation where too many birds quickly become a nuisance to the public in some settings.

"It's like feeding a person a daily diet of donuts," Walker said. "If most of a diet is filler ingredients with no nutrients, there won't be a healthy result."

Walker said the solution is to simply stop feeding the geese and allow them to find natural foods that meet their biological needs.

"If everyone stops feeding the geese, they won't disappear," she said. "Families can still enjoy viewing geese and parents can teach children how to respect the geese, learn about them and help them by not interfering."

#### City of Lee's Summit's Restrictions on Feeding Wild Animals

Sec. 5-11. - Feeding of certain wild animals prohibited.

- A. Prohibitions.
  - No person shall feed or in any manner provide any attractant to any wild animal within the corporate limits of the City.
  - 2. No person shall leave, store, or maintain any attractant in a manner, area, or location accessible to any wild animals within the corporate limits of the City.
- B. Exceptions.
  - 1. Any person who is the legal owner of a wild animal and the wild animal is kept in compliance with all applicable state and local laws.
  - 2. Any person who feeds or provides food to a trapped, injured or unweaned wild animal between the time that the City of Lee's Summit Animal Control Department is notified of the wild animal and the wild animal is picked up by the City of Lee's Summit Animal Control Department or its designated agent.
  - 3. Any person with a bird feeder intended to feed song birds, provided the feeder is suspended on a cable or other device to make it inaccessible to wild animals, and the area below the feeder is kept free from the accumulation of seed debris.
  - 4. Any person feeding animals in the normal course of raising farm animals for food production or in the care of livestock animals, provided all reasonable efforts are made to reduce attractants to wild animals in the course of feeding livestock/ farm animals and in the storage of animal feed.
  - Nothing in this section shall restrict citizens' ability to maintain ornamental plants or vegetable gardens on their property, provided all reasonable efforts are made to reduce wild animals feeding off of such ornamental plants or vegetable gardens.
  - 6. Nothing in this section shall prohibit the actions of agents of the City of Lee's Summit Animal Control Department, Missouri Department of Conservation, their authorized agents or other individual(s) acting lawfully pursuant to wildlife or waterfowl management programs duly authorized by the City of Lee's Summit, the State of Missouri, or the Federal Government of the United States of America.

#### Home Improvements May Need Approval!!!!

Before you start maintenance on your home this coming spring, remember that exterior changes may need approval from the Architectural Review Board (ARB).

To accommodate residents' needs, the ARB meets the first and third Monday of each month.

Applications to be considered need to be turned into the office the Thursday prior to the meeting. Please plan ahead when planning a project and get your approval early because after approval, you are allowed 6 months to begin the project.






