Meeting called to order at 7:00pm CST

Bob motions to approve the November minutes, Scott seconds, the vote is unanimous

Open Forum

- Residents given 10 minutes each to talk on lake changes. Highlights are:
 - o Jess Harter presented wake research data
 - Important point is wake dissipation with distance
 - At 100 feet wake is nearly comparable to runabout at 100 feet
 - At 300 feet wake is negligible different than runabout at 300 feet
 - Watersports are a large draw to the lake
 - LET'S FIX THE PROBLEM
 - o Dock and slip design seems to be an issue
 - Enforcement of the rules we have would go a long way
 - Concerns raised with teaching younger children watersports at slow, plowing speeds are required for teaching purposes
 - Need to think forward and come up with progressive ideas and solutions
 - Lifts seem to be an issue with capacity and use.
 - Perhaps a deposit required for maintenance/removal if required
 - Need to keep Raintree Lake unique and keep it going culturally. Watersports are a part of the culture

Old Business

 - o Proposed rule changes given to the lake committee
- Boating safety articles
 - Progress is being made
- Boat approval process/training
 - o Lance and Scott to meet with Rachelle
 - Preview test if it is available
- Dock Specifications
 - o Dan has concerns that the problem is not exactly defined, David seconds that fact
 - o Dock repairs need to be implemented and evaluated

 - Need to determine the preferred anchoring area
- Enforcement of existing lake rules
 - This has been addressed, removing from agenda items

New Business

- Proposed rule changes
 - o See attached document for all proposed changes
 - o Unclear exactly what the problem being solved was
 - Weight restriction needs more research to determine appropriate weight
 - Enhanced weight removed until dock repairs and reinforcement are complete and evaluated
- Rich proposes wake surfing to be allowed on North arm of the lake only, near the middle so waves have adequate room to dissipate.
 - Lake committee agrees with the proposal
 - o Added to proposed rule changes under VIII Watersports Rules
- Anchoring area
 - Designate the first 100 feet from the dam as anchorage and to be marked with buoys
 - Will help with normal traffic flow
 - o Added to proposed rule changes under VII Miscellaneous Operating Rules
