Unfinished Business

- Wake Surfing rule considerations
 - Based on proposed rule changes that are
 - Wake surfing prohibited, addition to section IX
 - Watercraft restrictions, section II, 1 (c)
 - Vessels shall not exceed the following lengths, width and weight Motor boat: twenty-one (21) feet and 3,500 lbs maximum dry weight as shipped from the manufacturer and listed in the manufacturer specifications
 - Water Sports, section IX, 9
 - No vessel shall create an enhanced wake through any means, including but not limited to internal ballast tanks, external ballast bags, wedges, wake gates or plates, wave gates and/or tabs, hulls designed for additional water displacement and computerized wake enhancement systems, to increase the wake created for a duration longer than 20 seconds (time allowed to go from plowing to on-plane).
 - o Discussion held about the proposed rules that included
 - Impact on other boaters
 - Impact on the shoreline
 - Impact on the lake bottom
 - Overall impact on the lake
 - Proposed Rule: Wake surfing prohibited

- David C. motions, Brian seconds
- Vote is 5 yay, 4 nay, 1 absence
- The Lake Committee recommends wake surfing be prohibited
- Append to section IX, Water Sports
- Proposed Rule: Watercraft restrictions, section II, 1 (c)
 - 1. Vessels shall not exceed the following lengths, width and weight
 (c) Motor boat: twenty-one (21) feet and 3,500 lbs maximum dry weight as shipped from the manufacturer and listed in the manufacturer specifications
 - Motion to approve by David C., John M. seconds
 - 4 yay, 5 nay, 1 absent. Vote fails
 - David S. proposed a 4100 lb weight limit
 - David S. motions, David C. seconds
 - Vote is 5 yay, 2 nay, 2 abstain, 1 absent
 - Proposed rule modification passes
 - Proposed rule change is:
 - 1. Vessels shall not exceed the following lengths, width and weight
 - (c) Motor boat: twenty-one (21) feet and 4,100 lbs maximum dry weight as shipped from the manufacturer and listed in the manufacturer specifications
 - Previously approved vessels not meeting these requirements would be grandfathered in
- Proposed Rule: Water Sports, section IX, 9
 - No wake enhancements to be used while plowing for more than 20 seconds. Wake enhancements may be used while participating in towed water sports.
 - Unrecorded who motions or seconds
 - Vote is 1 yay, 5 nay, 3 abstain, 1 absent
- Proposed Rule: Surfing restrictions, added to section IX
 - Wake surfing is not allowed Saturdays, Sundays, and July 4 between the hours of 12 pm and 5 pm the months of June, July, and August.
 - Scott motions, Dan seconds
 - Vote is 4 yay, 5 nay, 1 absent. The proposed rule fails the vote
