## **New Business**

Resident request to create a launch for kyak's. Jess & Rich to review the location around Champagne Point, materials to be utilized and provide feedback to the committee.

As requested by Supervisor of Lake Patrol and General Manager, review of Lake Regulations administration and associated penalties. Dan provided year to date total of 28 violations. Of those 28 violations 22 consists of no boat permit or no stickers. 23 of these were fined. There has been 1 lake suspension.

Tom motioned for Lake Committee to resume control of Lake Patrol Supervision. Members voted and decision of 6-1 declined. No recommendation to change current reporting.

Committee resumed review of all Lake Regulations and proposals to increase penalties submitted by David Campbell.
