  - 11 judgements, 1 bankruptcy, 1 foreclosures, 0 making payments, 31 demand letters, 2 court cases & \$8,577.22 delinquencies paid.

# 7. UNFINISHED BUSINESS

- A. Lake Committee Rule Change regarding boat weight max of 4100 lbs.
  - The Lake Committee was tasked to come up with a proposal regarding an appropriate maximum weight limit for watercraft.
  - This item was discussed at length in multiple Lake Committee meetings.
  - The committee reviewed 25 different 21 ft. boat models.
  - Ultimately the committee proposed a 4100 lbs. max dry weight limit.
  - Lift max limits were not a determining factor in their decision, although they did verify the new limit would be under the max lift limit.

- The Board discussed their recommendation and the fact that surrounding lakes have also adopted a maximum weight limit.
- The Board thought that choosing a limit in line with the area was needed to help limit RLPOA liability.
- The lake committee was tasked with coming up with a proposal for grandfathering existing lake vessels that are above the new limit.
- Motion to accept the Lake Committees recommendation of a 4100 lbs. dry weight limit to go into effect at the end of the current boating season: JC

# B. Water Patrol Lift \$10,157.35

- The new CH dock will have a single well slip for the Water Patrol's Trophy Boat and will need a lift installed when the dock is completed.
- The new lift will be 4 point side mounted.
- In the discussion on how to finance this lift, Josh stated that we received \$6,000 from the Little Blue Sewer District for an easement and over \$5,000 from insurance for the damaged light pole at the 291 entrance. Both of these were not included in our revenue projections for the year.
- Motion to approve up to \$10,500 from Sewer District and insurance funds for a new side mounted lift for the Trophy Boat: Kelly Bride
- 2nd: JC
- Approved 5-0

#### C. Dock Electrical upgrade - \$86,400 Docks-V,O,Q,L,H,I,CH 1&2,T

- The 2025 budget has \$50,000 approved for the dock electrical upgrade to the Lake of the Ozarks standard.
- Josh requested the Board also approve spending the leftover dock electrical funds from 2024.
- The Board would like the time to discuss the current state of the budget and roll over funds before approving anything beyond the 2025 \$50,000 allocation.

#### 8. NEW BUSINESS

- A. Raintree Rays Swim Team
  - With all the snow/cold day school cancellations this year resulting in the final school day to be extended a week, the Rays wanted to discuss a revised training schedule for the team.
  - A preliminary plan of May 19-22, 27-30 and June 2 late afternoon/early evening window was recommended. The plan will still need coordination with the Pool Management Company before finalization.
  - RLPOA sponsorship of the team was also discussed.

- Motion to approve \$700 from acct #8007 to sponsor the 2025 Raintree Rays Swim Team: JC

### B. The Mapping Network Sediment Analysis

- Brian Ratigan, Chair of the Siltation Committee was present to discuss the overall siltation plan and what the committee would like to accomplish in 2025.
- He obtained bids for the sediment mapping of the 8 estates ponds, Party Cove and Mullendyke and proposed that Party Cove and Mullendyke were the priority for this year.
- The Board decided to postpone the decision until more data is available from the Hidden Cove cleanout.
- This item will be discussed again at the July Board meeting.

#### C. Garden Club Butterfly Garden Update

- Blanche McWilliams was present to discuss the Garden Clubs ideas for the Butterfly Garden in 2025. A new trellis will be installed and a new sign will be added at the end of the year.
- The Board thanked the Club for all its hard work in making Raintree Lake a beautiful community.

#### D. Boat Lift Guidelines

- Boat Lift Guidelines were again discussed by the Board.
- The idea of incorporating these guidelines into the Minimum Specification for Boat Docks document was also debated.
- Josh will compile the data to be presented at the April Work Session.

#### E. Sublease Fee Fine Requirements

- There have been instances in the past where docks were found to be subleased without the sublease fee and documentation being submitted to the office.
- These instances put the RLPOA in a precarious position if an accident occurs to a person on the dock with no liability agreement.
- The idea of an implementation of a fine when these cases are found to discourage this behavior.
- There will be an education campaign to let everyone know of this fine structure before implementation.
- Motion to institute a fine, starting after an educational period, for subletting a slip without the proper fee and documentation provided to the RLPOA reading "First violation will result in a \$200 fine and the second violation will result in a \$500 fine and loss of the sublease for that season": Charlie

- The tractor is used to pull the batwing mower and is an essential piece for our common ground maintenance.

- Additional rock is also needed for proper rip rapping of the shore.
- Josh will present the information when it becomes available.
